THE McELROY FAMILY

<u>Introduction</u>

In Chart's Pedigree, the name McElroy can be traced back a thousand years. One of the proofs that it is a very old name is found in the fact that it belongs to both Ireland and Scotland and is common to both Catholics and Protestants. The McElroy arms are described as follows: On a bend azure, a star of six points between two crescents argent, and in a base a bow and arrow of the second. Crest: A hand, erect, holding a battle axe ppr. Motto: "TRUSTY AND TRUE."

Various books and records are found on one James McElroy, who about 1729 sailed on the vessel "GEORGE AND ANNE! in company with Irvins, McDowells, McCunes, and others, and first settled on the borders of Pennsylvania. Later James McElroy and John Irvine, a Presbyterian minister, moved south and settled in Campbell Co., Va. James had five sons: John, Archibald, Hugh, Samuel and James. Hugh, Samuel and James McElroy married three Irvine sisters.

Our JOHN McELROY does not appear to be the son of the above James, as he was born about 1690. McElroys show up as early as 1659 in Maryland Land Grants. Each immigrant coming to Maryland was entitled to a grant of land. The two McElroys were listed as "transported" which means their passage was paid for by someone else, and usually meant they had to work out their passage from some large land holder. The two McElroys listed were:

ARCHIBALD MUCKELL, Liber 4, Folio 55, transported 1659. PATRICK MACKLEROY, Liber 18, Folio 137, transported 1674.

There is no proof, but I think the above ARCHICALD MUCKELL was the grandfather of our John McElroy. The name Archibald was passed on down through the generations, and our Isaac was listed in the 1820 Franklin Co., Tenn. census as ISAAC MUCKLE (the short form of McElroy). In the court records of Maryland, Virginia, North Carolina, Georgia, Mississippi and Texas, the McElroy name is spelled in various ways. JOHN's name is MACKLEROY in the Harford County, Maryland records. Archibald's name is MACKLEROY in his will found in Johnson Co., North Carolina. Avington's name was spelled MACKLEROY in North Carolina, but in Georgia he ran a ferry named MUCKEL'S FERRY. ISAAC's name is spelled MUCKLEROY in Georgia, MUCKLE in 1820 Franklin Co., Tenn. census, and the name is McLEROY in his will. It is said that his daughter, Jane used the name of MUCKLEROY in Miss., yet her name is given as McROY in Mississippi History. All of Isaac's sons who came to Texas used the name MUCKLEROY. Georgia records also show McKLEROY, McELROY, McLEROY.

M c E L R O Y...spelling variants

McElroy in this instance is used for spelling variants such as McLeroy, Muckelroy...etc.

The form McLeroy was first used by this branch of the family by Edward McLeroy (1783-c.after 1850). His father was John McElroy and it is not exactly sure when Edward first used the form McLeroy. He was referred to in a Deed Gift from his grandfather as Edward Snicher McKleroy. This was 1796. He was listed in the 1830 census as McElroy, the 1840 census as McKleroy and the 1850 census as McLeroy. Spelling in many instances in census varies with the census taker.

Edward McLeroy's son Henry used McLeroy in deeds, marriage and other legal documents. However, again census records vary. As far as is known all descendants of Henry McLeroy use the McLeroy form.

McElroys originally came from Scotland, Ireland and present day Northern Ireland (Ulster). The spelling originally in Ireland was Mac Giolla Rua, and in Scotland and Ulster was Mac'Illeruaodh. Other spellings known in Scotland were M'Gilerio, M'Ylroy, Mackgilroy, M'Ilroy. Scottish spellings that were generally used in the United States were McElroy, McLeroy, McIlrie, McIlroy. Reference: The Atlanta Journal and Constitution 10/12/1972.

Research by Mrs. Carmae Massey Smith, 4614 Ivanhoe St., Houston TX 77027 indicates that the likely ancestral home of this branch of McElroys is County Sligo in the ancient Kingdom of Connaught, Ireland.

From Irish Families, by Edward MacLysaght, page 134...

"McELROY, MacGilroy, Kilroy. The name is Mac Giolla Rua, in Irish, i.e. son of the red (haired) youth. The sept (clan) originated in County Fermanagh where the place name Bally-mackilroy is found: their territory was on the east side of Lough Erne. There is another Ballymackilroy in County Tyrone and another in County Antrim. In the seventeenth century census (1659) the name is recorded as very numerous in County Fermanagh and also in County Leitrim-the latter as MacGilleroy.

It is still numerous in the same areas, but in Connacht the modern spelling is often Kilroy or Gilroy, without the Mac***

Note: Counties Fermanagh, Tyrone and Antrim are in Ulster and Counties Sligo and Leitrim border, with both being in Ireland. Leitrim having a border common with County: Fermanagh, Ulster.

JOHN McELROY, born ca 1690; married before 1713, Frances The birth dates of their children are recorded on microfilm in the Hall of Records, Annapolis, Harford County, Maryland 1681-1799, St. George's Parish Register of Harford Co., Maryland, pgs 52 & 53.



While there is no actual proof, it appears logical that Archibald Muckle, Liber 4, Folio 55, transported to Maryland 1659 was the grandfather of 10.JCHN McELROY.

Transported means that he was bound out for a period of time in payment for passage. At the end of servitude, land was usually granted.

Deeds as late as 1732 place 10. JOHN McELROY in Baltimore County MD.

Reference:St. George Parish Register, Harford County Maryland 1681-1799 pages 52 and 53, on microfilm. Hall of Records Annapolis, MD. Also lists children of John and Frances McElroy.

John McElroy III, and sale of property in Wilkes County moved to Oglethorpe County with said son 8. John McElroy III. Sale of property was to James McKleroy, another of his sons and was for 500 acres in 1798.

Many were her afflictions; but the Lord had delivered her our of them, and finally translated her from this world to the world of spirits, where her friends confidently hope she rests from all her tribulation Henry. died unmarried. Will dated 7/1/1848 Harris Co. GA, Will Book A p 130; to niece Frances Hartsfield (evidently daughter of his sister Pellatiah), piano, forte and 10 slaves, plus 1 mulatto boy in possession of Christiana McElroy, to remain in possession of said Christiana McElroy during her lifetime; to nephew 6. Henry McElrov of Favette Co GA (note: this would be the son of his sister 7, Mary "Polly" who married 7. 

Henry McLeroy owned and operated a cotton plantation of over 1200 acres on present day Tara Road in Clayton County (then part of Fayette County GA). He completed a home that was partially built and later sold it to Philip Fitzgerald, great-grandfather of



Margatet Mitchell, author of Gone With the Wind. Philip Fitzgerald made additional changes, especially after the Civil War. Philip Fitzgerald, born in Ireland, had lived in Fayette County several years before purchasing the property. The sale of 8/9/1853 is recorded in Fayette County Superior Court Book G 1851-1857 page 399. The price was \$4,800. plus a tract of land in Florida.

Before the Macon and Western Rail Road (now Central of Georgia) came thru Jonesboro to join the Western and Atlantic and the Georgia Rail Roads in Atlanta, planters would carry cotton and other farm products to Savannah caravan wagon style.

After selling their products, or consigning to export merchants merchants they would purchase for return such items as needles, sugar, spices, coffee, etc. not produced on self-contained plantations of central Georgia in the 1840's. Much of the mill work for the home was brought from Savannah and Milledgeville by mule or horse caravan.

After visiting the Florida agreage for inspection, Henry McLeroy caught fever and died in the fall of 1853. Made will on death bed October 1 1853. Directed executor of will, Millegan Bert DeVaughn (his son-in-law) to sell the then occupied property and buy new land for widow; to provide funds for the education of minor children.

The will also directed that all slaves, except seven (these seven were named) be sold on the block. His widow, provided she did not remarry was to receive \$1500. for the next two Christmases besides immediately receiving \$3000. cash. Unmarried children were to receive \$1200. each to compensate for earlier gifts to married children. Will recorded Fayette Co.GA Book A pages 122,123 & 124.

GEORGIA FAYETTE COUNTY: In the name of God Amen, I Henry McLeroy of the State and County aforesaid, being of advanced age, and knowing that I must shortly depart from this world deem it right and proper both as respects to my self and family that should make a disposition of the property which a kind providence has blessed me. I therefore, make this my last will and testament hereby revoking and annulling all others heretofore made by me.

Item first, I desire and direct that my body be buried in a decent and Christian like manner suitable to my circumstances and condition.

Item second, I desire and direct that all my just debts be paid without delay by my Executor herein after named, as I am unwilling my creditors should be delayed of their rights especially as there is no necessity of delay.

All the before named property I give to my wife Martha and during her natural life, though if she up marry after my death I wish my Executor to take Management of said property and apply income of said property to the support of my wife and for the raising and educating of my minor children. After the death of my wife Martha McLeroy I wish this property all be sold and Equally divided between all

my children. Also I wish my minor children to be raised and educated out of the proceeds of this property if my wife Martha does not marry.



However, her mother was quick to forgive and presented the young couple with farm, house, live stock and implements as a wedding present.

1860 Clayton County census shows B. M. Travis age 26 and wife M. F. Travis age 18 with real estate valued at \$1600. and personal property listed at \$1000...this represents the gift refered to above.

Martha Frances McLeroy Travis Allen wrote under the authorship of "Grandma Fannie Allen" a newspaper column for the Claytom County News and Farmer.

These articles started around 1928 and continued until shortly before her death in 1934.

These article dealt principally with life on the plantation before the Civil War and news about families in the Jonesboro area in the late 19th century.

She kept up an extensive correspondence with old friends and relatives.

8.CAPT. JOHN HOLMES...Revolutionary Soldier b.1747 Caroline County Virginia d.1803 Wilkes County Georgia

There are numerous contridictions on the life and activities of John Holmes. I will herein record what is most widely accepted by DAR applicantions, and other references on record at the Georgia Department of Archives and History. References regarding disagreements are either attached, or refered to, for further study.

He came to the Carolinas from Virginia, and then to Georgia. The South Carolina Historical and Genealogical Magazine, Issue I, page 270 shows that he was in Georgia as early as 1760. Wilkes County Georgia records prove that he was in Georgia (Wilkes County) by 1784. Other references indicate that he was licensed to teach English and Latin in Savannah in 1766 by Sir James Wright, Govenor of the Colony of Georgia.

He was appointed Chaplain in General Lachlin McIntosh's 1st Georgia Regiment, 2/16/1776. Prior to that he was Rector of Begoria Church in Burke County. Was one of the founders of the Georgia Chapter of The Society of the Cincinnati.

I page 75 refers to will signed 9/4/1802, -probated 3/8/1803.

<u>Penelope</u>, b. 1773 <u>m. Benjamin Milner</u>, son of Pitt Milner. If this is correct she was probably 20 or 25 years older than her husband. Benjamin could have been the brother of Pitt Milner.

Mary m. 1s. Ezekiel B. Parks. m. 2nd Elisha Kendall.

Josiah B. DAR 431867 shows birth as 1788 NC and marriage to Amelia Williams. DAR 597673 lists Josiah 1st suggesting that he was the eldest child, therefore being born before 1770.

Note: Evidently two Josiah B. Holmes living at about the same time in the same general area. The Hartsfields of America by Hartsfield and Clover, page 51 lists Josiah B. Holmes as husband of Sarah Hartsfield, the first child of Godfrey and Sarah Sallie Simms Hartsfield, and sister of 7.ELIZABETH who married 7. WARREN HARTSFIELD.

There are conflicting dates as to the birth of Elizabeth born GA and Josiah as shown by some as North Carolina 1788. Bounty Land Application 254709 on file in the National Archives, Washington DC shows birth date of Elizabeth Holmes Hartsfield as 1788, birth place Georgia, her maiden name and marriage date by Rev. Ben Milner (probably her brother-in-law, husband of Penelope. Shown in 1850 Henry County Census as age 62 and birth place GA. The Will of John Holmes makes grants to Elizabeth and Moses upon reaching majority, indicating that the other children were older. John Holmes was involved in the appraisement of property in Wilkes County in 1786 (DAR Historical Collections Vol II (#369) Carnegie Library, Atlanta). Two John Holmes shown in the 1790 NC census and the discription does not seem to fit this John Holmes.

Note:information referring to place of death of <u>William Bentley</u> is in <u>error</u>. DeKalb County was not created until 1822. A land grant in 1784 in Wilkes County and other Wilkes County GA references would indicate the place of death as Wilkes Co. GA. In addition, his daughter and son-in-law John Holmes were living in Wilkes Co. GA 1802.

date of 1806 shown is probably the result of an estate settlement becerence:Davidson's Wilkes County Volume II pages 239 & 240. All DAR papers that I have seen show the death date as 1803.

Davidson's Wilkes County Volume I page 75 shows will dated 9/4/1802 and probated 3/8/1803, Wilkes County Georgia. The settlement refers to children: Apsylla Milner, Penelope Milner, Mary Parks, Josiah, John, James (called oldest), Moses and Elizabeth. The will stipulates settlements for Elizabeth and Moses upon reaching majority, indicating that all other children were over 21.

DAR Patriot Index p 339 shows John Holmes b.c.1735 d.p.9/4/1802 (the date of the will) and married to Chloe Bentley.

Note: The reference that Penelope Holmes married Benjamin Milner son of Pitt Milner is evidently in error. If this is correct she would be about 25 years older than her husband, who would also be her nephew! History of Jones County Georgia page 654 shows Pitt Milner and Rev. Benjamin Milner, brothers, and sons of Capt. John Milner a Revolutionary Soldier.

Bounty Land Application 254709 (by widow of soldier War 1812) shows that Elizabeth Holmes was married to Warren Hartsfield by Rev. Ben Milner, evidently her brother-in-law. Rev. Benjamin Milner was probably a Primitave Baptist Preacher.

The McLEROY-HARTSFIELD family connection

McElroy in this instance is used for spelling variants such as McLeroy, Muckelroy, McKleroy...etc. The form McLeroy was first used by this branch of the family by Edward Snicher McLeroy, although it had been used previously by some of his relations. It is not sure when first used. A deed gift of 9.William McKleroy lists his grandson as Edward Snicher McKleroy. Frequently spelling will vary within the same document. He is listed in the 1830 census as McElroy; the 1840 census as McKleroy and the 1850 census as McLeroy. Spelling also varies with the census taker. Numerous intermarriages between the Hartsfield and McElroy families took place from the time the two moved at about the same times from Maryland to North Carolina to Georgia. This chart will concern itself principally with that branch of the family using the McLeroy style of spelling and Henry McLeroy who married into the Hartsfield family in 1829.
